Bylaw Review Process

The 2018 Bylaws Committee met via conference call to consider proposed amendments to the Quota International bylaws. The pros and cons of all proposals were thoroughly discussed. All suggestions were studied and researched to ensure they were technically correct, made sense, and did not conflict with other standing bylaws. The committee members served as stewards of the organization and reviewed each bylaw submission with regard to whether it was for the general good of the organization. Action was taken on each proposal by conference call vote followed up with an email vote.

White-Sheeted Bylaws

Proposed Amendments were approved by the Bylaw committee relating to *Quota International Officers Named, Eligibility and Term, Duties, Nominations and Elections, and Regions Regional Officer*. These are attached for your review and will be discussed and voted on by the delegates at the bylaws session at Convention in Washington, DC, on Wednesday, July 11th, 2018. They are provided on white paper.

Green-Sheeted Bylaws

Proposed amendments not endorsed by the committee and not recommended for discussion at convention are provided to you on green paper for easy identification. This year, five proposed bylaw amendments were green-sheeted. Green-sheeted proposals may be lifted by a majority vote and then discussed and voted on by the body.

The Bylaw Amendments will be discussed on the All Leadership Conference Calls scheduled the last week in May.
